


Two tasks from the client website.sitemap.xml to the client Google Search Console:

1. Submit the client sitemaps listed on the first page of client website.sitemap.xml to all four properties (1. http, 2. https, 3. http://www, 4. https://www) in the client Google Search Console.




2. Submit ("Force Index") on the client Google Search Console **11** URLs found on the client website.sitemap.xml that contain keyword combinations from the client Keyword.com page.

Setup

You'll start the setup of client **Sitemap** and **Indexing** tasks by opening five items (tabs) split between two separate browser windows.

The First Browser Window

- 1. Intern@Hozio.com website to get email with link to an Excel spreadsheet.
- 2. Excel Spreadsheet, accessed from email (above). From the spreadsheet, first copy the email address (re: tab 5. later) and then click on the client Keyword.com link to open the client Keyword.com website page.



The Second Browser Window



Incognito Mode

Open three remaining tabs in "Incognito Mode" by clicking on the button at top right of browser. Incognito mode is indicated to the user by the black top tab, URL address, and menu bars at top of browser (pictured below).



- 3. Keyword.com using the link from the Excel spreadsheet. Then cut and paste the primary URL, displayed as the header, in boldface print at the top of the Keyword.com page, to access the clients website. View the client's website to make sure it is working properly before next step.
- **4. Client's Website Sitemap** by adding "/sitemap.xml" to the client's website (e.g client's website/sitemap.xml).
- Google Search Console using the client's email address (paste from step 1.) and default password from the Excel spreadsheet. Click on the Sitemap option at left.

Setup (cont.)


In addition to the five tabs, from the fifth tab, the client Google Search Console, we will open an additional three tabs.



1. Right-click on the fifth tab, the client **Google Search Console** (pictured above) - the third tab in incognito mode - and select **Duplicate** three times to create an additional identical three tabs, making a **total of four** identical client **Google Search Console** tabs (pictured below).



- 2. Click on the Sitemaps option at middle left (pictured below).
- **3.** Using the **Properties** selection pull down menu at top left (four property options. . . **1**. https, **2**. https, **3**. http www, **4**. https www), select a different property for each of the four client **Google Search Console** tabs.



Execution: Sitemaps and Indexing


1. Submitting Client Sitemap URLs to the Client Google Search Console

Submit the main client sitemap URL (i.e. the client **website.sitemap.xml**) and all the client sitemaps listed on the first page of client **website.sitemap.xml** to all four properties (1. http, 2. https, 3. http www, 4. https www) in the client **Google Search Console**.

- 1. Copy the end of the URL address only (from the "/" forward, not including the "/").
- **e.g.** https://www.examplewebsiteurl.com/sitemap.xml https://www.examplewebsiteurl.com/sitemap-pt-post-2021-08.xml https://www.examplewebsiteurl.com/sitemap-pt-post-2021-06.xml
- 2. Paste from client **Keyword.com** page to the client **Google Search Console**.




2. Forced Indexing

Submit (Force Index) to the client **Google Search Console 11** URLs found on the client **website.sitemap.xml** that contain keyword combinations from the client **Keyword.com** page.

1. In the client **Keyword.com** page click on the **Page** heading to view URLs with a value of less than 1.



2. Copy <u>11</u> keyword search terms from the client **Keyword.com** page to any clipboard ("Sticky Notes" pictured below), adding hyphens between each of the words.




2. Forced Indexing (cont.)

Find URLs that include keyword combinations on the client website/sitemap.xml

1. Click on each of the links on the first page of the client website/sitemap.xml to access the subdirectories.



2. Copy and paste keywords from the client **Keyword.com** page (with hyphens added in between the keywords) into **Find** (ctrl + **F**) in <u>each</u> of the client website/sitemap.xml subdirectories to find URLs that include the keyword combinations.



2. Forced Indexing (cont.)

3. Submit the URLs (full URL address) found containing the keyword combinations **to the matching property** in the client **Google Search Console** (**e.g.** if the URL starts begins with **https**, search on the **https** property only; if the URL begins with the **http www** property, search on the **http www** property only . . .).


